



Key Stage 1 and Key Stage 2 Curriculum Policies

ART AND DESIGN

1 Aims and objectives

- 1.1 Art and Design stimulates creativity and imagination. It provides visual, tactile and sensory experiences, and a special way of understanding and responding to the world. It enables children to communicate what they see, feel and think, through the use of colour, texture, form, pattern and different materials and processes. Children become involved in shaping their environments through Art and Design activities. They learn to make informed judgements and aesthetic and practical decisions. They explore ideas and meanings through the work of artists and designers. Through learning about the roles and functions of art, they can explore the impact it has had on contemporary life and on different periods and cultures. The appreciation and enjoyment of the visual arts enrich all our lives.
- 1.2 Our objectives in the teaching of Art and Design are:
- to enable children to record from first-hand experience and from imagination, and to select their own ideas to use in their work;
 - to develop creativity and imagination through a range of complex activities;
 - to improve the children's ability to control materials, tools and techniques;
 - to increase their critical awareness of the roles and purposes of Art and Design in different times and cultures;
 - to develop increasing confidence in the use of visual and tactile elements and materials;
 - to foster an enjoyment and appreciation of the visual arts and a knowledge of artists, craftspeople and designers.

2 Teaching and learning style

- 2.1 The school uses a variety of teaching and learning styles in Art and Design lessons. Our principal aim is to develop the children's knowledge, skills and understanding. We ensure that the act of investigating and making something includes exploring and developing ideas, and evaluating and developing work. We do this best through a mixture of whole-class teaching and individual or group activities. Teachers draw attention to good examples of individual performance as models for the other children. They encourage children to evaluate their own ideas and methods, and the work of others, and to say what they think and feel about them. We give children the opportunity to work, by themselves and in collaboration with others, on projects in two and three dimensions, and at different scales. Children also have the opportunity to use a wide range of materials and resources, including Information and Communication Technology (ICT).
- 2.2 We recognise the fact that we have children of differing ability in all our classes and we provide suitable learning opportunities for all children by matching the challenge of the task to the ability of the child. We achieve this through a range of strategies:

- setting tasks that are open-ended and can have a variety of responses;
- setting assignments with tasks of increasing difficulty, where not all children complete all tasks;
- grouping children by ability and setting different tasks for each group;
- providing a range of challenges with different resources;
- having more adults support the work of individual children or small groups.

3 Art and Design curriculum planning

- 3.1 Art and Design is a foundation subject in the National Curriculum. We use the national scheme of work as the basis for our curriculum planning in Art and Design. We have adapted the national scheme to our particular circumstances in that we use the local environment as the starting point for some aspects of our work.
- 3.2 We carry out the curriculum planning in Art and Design in three phases: long-term, medium-term and short-term. Our long-term plan maps topics studied in each term during each key stage, taking into account integration opportunities within the Jewish calendar and general Jewish topics of study. The subject leader and Head of Kodesh draw up this curriculum map in conjunction with teaching colleagues in each year group.
- 3.3 Our medium-term plans, which we have adopted from the Qualifications and Curriculum Authority (QCA) national scheme, give details of each unit of work for each term. These plans define what we will teach and ensure an appropriate balance and distribution of work across each term. The subject leader is responsible for keeping and reviewing these plans.
- 3.4 Class teachers complete a daily plan for each Art and Design lesson. These list the specific learning objectives and expected outcomes, and give details of how to teach the lessons. The class teacher keeps these individual plans and the class teacher and subject leader often discuss them on an informal basis.
- 3.5 We plan the activities in Art and Design so that they build on the children's prior learning. While we give children of all abilities the opportunity to develop their skills, knowledge and understanding, we also plan progression into the scheme of work, so that there is an increasing challenge for the children as they move up through the school.
- 3.6 Wherever possible and appropriate, we integrate Art and Design with kodesh subjects. For example, making specific festival artwork within a QCA unit scheme of work.

4 The Foundation Stage

- 4.1 We use the document "Curriculum Guidance for the Foundation Stage" (DfEE/QCA) to inform planning in the Nursery and Reception classes.
- 4.2 We encourage creative work in our Foundation Stage classes, as this is part of the Foundation Stage of the National Curriculum. We relate the children's creative development to the objectives set out in the Early Learning Goals (Creative Development), which underpin the curriculum planning for children aged three to five. The children's learning includes art, music, dance, role-play and imaginative play. The range of experience encourages children to make connections between one area of learning and another, and so extends their understanding.
- 4.3 Our Foundation Stage curriculum policy, **Creative Development**, as well as our Foundation Stage policy **Care Learning and Play** contain more detailed information regarding Art and Design teaching and learning in our Foundation Stage classes.

4.4 We provide a rich environment in which we encourage and value creativity. Children are engaged in a wide range of activities and their responses involve the various senses. We give them the opportunity to work alongside artists and other adults. The activities that they take part in are imaginative and enjoyable.

5 Contribution of Art and Design to teaching in other curriculum areas

5.1 Literacy

Art and Design contributes to the teaching of Literacy in our school by encouraging children to ask and answer questions about the starting points for their work. They have the opportunity to compare ideas, methods and approaches in their own work and that of other children, and to say what they think and feel about them.

5.2 Numeracy

Art and Design contributes to children's mathematical understanding by giving opportunities to develop the children's understanding of shape and space through work in two and three dimensions.

5.3 Personal, social and health education (PSHE) and citizenship

Art and Design contributes to the teaching of some elements of personal, social and health education and citizenship. The children discuss how they feel about their own work and the methods and approaches used by others. They have the opportunity to meet and talk with artists and other talented adults during their work.

5.4 Spiritual, moral, social and cultural development

The teaching of Art and Design offers opportunities to support the social development of our children through the way we expect them to work with each other in lessons. Groupings allow children to work together and give them the chance to discuss their ideas and feelings about their own work and the work of others. Their work in general helps them to develop a respect for the abilities of other children, and encourages them to collaborate and cooperate across a range of activities and experiences. The children learn to respect and work with each other and with adults, thus developing a better understanding of themselves. They also develop an understanding of different times and cultures, through their work on famous artists, designers and craftspeople.

6 Art and Design and ICT

6.1 ICT enhances our teaching of Art and Design, wherever appropriate, in all key stages. Children use software to explore shape, colour and pattern in their work. Older children collect visual information to help them develop their ideas by using digital and video cameras and scanners etc. They record their observations and they manipulate them through photo-editing or painting software to create mythical creatures. The children also use the Internet, to find out more about the lives and works of famous artists and designers, and to assemble their own presentations about them.

7 Art and Design and inclusion

7.1 We teach Art and Design to all children, whatever their ability and individual needs. Art and Design forms part of our school curriculum policy to provide a broad and balanced education for all our children. Our teachers provide learning opportunities that are matched to the needs of children with learning difficulties. We strive to meet the needs of all pupils with special educational needs, disabilities, special gifts and talents, and of those learning English as an additional language.

- 7.2 When the progress of a child falls significantly outside the expected range, then the child may have special educational needs. We assess the needs of each pupil, using a variety of techniques, and we take action to enable the child to learn as effectively as possible.
- 7.3 Intervention through School Action and School Action Plus will lead to the creation of an Individual Education Plan (IEP). This may include targets specifically related to performance in Art and Design, and the teacher will pay attention to these and other learning targets when planning lessons.
- 7.4 We enable all pupils to have access to the full range of activities while studying Art and Design. Where children participate in activities outside the classroom (a visit to an art gallery, for example), we carry out a risk assessment beforehand, to ensure that the activity is safe and appropriate for all pupils.

8 Assessment for learning

- 8.1 We assess the children's work in Art and Design while observing them working during lessons. Teachers record the progress made by children against the learning objectives for their lessons. At the end of a unit of work, we make a judgement against the National Curriculum levels of attainment. This is recorded in each child's **National Curriculum Record of Achievement booklet**. We pass these booklets on to the next teacher at the end of each year. The teacher records the level that each child has reached, and then uses this information to plan future work. This method of recording also enables the teacher to make an annual assessment of progress for each child, as part of the child's annual report to parents. When pupils move to new schools (either at the end of Year 6 or earlier) we pass each child's **National Curriculum Record of Achievement booklet** to the receiving schools.
- 8.2 Children are encouraged to assess and evaluate both their own work and that of other pupils. This helps them to appreciate how they can improve their performance, and what their targets should be for the future.
- 8.3 The Art and Design subject leader keeps evidence of the children's work in a portfolio. This demonstrates the expected level of achievement in Art and Design in each year of the school. Teachers meet regularly to review individual evidence of children's work against the national exemplification material produced by the QCA and the DfES.

9 Resources

- 9.1 We have a wide range of resources to support the teaching of Art and Design across the school. All our classrooms have a range of basic resources, but we keep the more specialised equipment in the Art and Design store. This room is accessible to children only under adult supervision.

10. Equal Opportunities (please refer further to our Equal Opportunities / Racial Equality policy)

- 10.1 We believe that every pupil should have the opportunity to achieve the highest possible standards.
- 10.2 We ensure that all children, irrespective of their ethnicity, attainment and ability, age, disability, gender or background, have equality of access to learning.
- 10.3 The curriculum we offer in the school encourages children to develop positive attitudes about themselves as well as to people who are different from themselves. It encourages children to empathise with others and to begin to develop the skills of critical thinking.

- 10.4 We recognise that children have different learning styles, making appropriate provision within the curriculum to ensure each child receives the widest possible opportunity to develop their skills and abilities.
- 10.5 We ensure that children learning English as an additional language have full access to the curriculum and are supported in their learning.

11 Monitoring and review

- 11.1 The coordination and planning of the Art and Design curriculum are the responsibility of the subject leader, who also:
- supports colleagues in their teaching, by keeping informed about current developments in Art and Design, and by providing a strategic lead and direction for this subject;
 - gives the Headteacher an annual summary report in which s/he evaluates the strengths and weaknesses in Art and Design, and indicates areas for further improvement;
 - uses specially allocated regular management time to review evidence of the children's work and to observe lessons of Art and Design across the school.
- 11.2 This policy will be reviewed at least every two years.
